City Council Direction

Council direction on October 7, 2014:

- 1. Create a commitment of intent to allocate \$15 million of the \$50 million dollars of the Chevron agreement to support for DMC as a full-service hospital.
- 2. Create a multi-year allocation plan to be implemented after the litigation is settled and with agreement from Chevron for accelerated money.
- 3. Develop a plan for additional funding with commitments from other sources.


- 2006: DMC Filed for Bankruptcy
- 2010: Affordable Care Act (ACA) adopted and implementation of *expanded coverage available since 2013*
- 2014 May: Measure C \$20 million Parcel Tax fails
- 2014 Sept.: SB 883 approved \$ 3 million from Major Risk Medical Insurance
- 2014 Oct.9: City of San Pablo issued an intent to Adopt a Negative Declaration rezoning the DMC site
- 2020: DMC Seismic Retrofit required




Exhibit 8: Estimated Travel Times from Doctors San Pablo to Nearby Hospitals

Ambulance Volume to DMC





Ambulance Volume to DMC





Measure C: Total Voters





DMC Stakeholder Group

- In May 2014, a Stakeholder Group led by Dr. William Walker, Director, Contra Costa Health Services was formed
- Examine finance solutions after failure of the parcel tax in May 2014
- Analyzing multiple health-care service models
- The Final Report scheduled for release in Fall 2014
- The Richmond City Council will receive an update on the Final Report within 30 days from issuance

Proposed Three-Year Funding Requirements

- All litigation resolved and building permit issued for Chevron Modernization Project
- DMC to remain open through end of 2017
- DMC & CCHS to present restructuring & financing plan
- Collaborative DMC Funding Strategy
- Implementation of sustainable West County healthcare system
- Passage of Parcel Tax required in second quarter of 2015
- No fiscal impact to the Richmond General Fund


